## THE INTERNATIONAL SOCIETY OF CRIMINOLOGY CONGRESS 2014

### CRIMSA EXPRESSION OF INTEREST TO HOST THE INTERNATIONAL CRIMINOLOGY SOCIETY WORLD CONGRESS IN SOUTH AFRICA IN 2014

At the 2007 AGM a decision in principle was made to explore the possibility of hosting the ISC Congress scheduled for 2011. In communications with the President of ISC, Prof Tony Peters, CRIMSA was informed that 2011 had already been allocated to the Japanese Criminology Society to host. However, CRIMSA were invited to formally submit their 'expression of interest' to host in South Africa the 2014 ISC Congress. This hosting offer was formally submitted by CRIMSA's president, Prof Anthony Minnaar, to the ISC Council meeting at the end of the International Society of Criminology conference held in Barcelona, Spain in July 2008.

At this Council meeting the Japanese Criminology Society were confirmed as hosts of the 2011 ICS conference to be held in Kobe, Japan. Some discussion on practical details ensued. After this discussion CRIMSA submitted their formal 'expression of interest' to host in South Africa the scheduled conference of 2014. This was accepted by the Council. However, unknown to CRIMSA the Chinese delegation, also attending the Council meeting, promptly verbally submitted their own expression of interest to host the 2014 conference in Beijing. As a result the ISC Council resolved that both CRIMSA and the Chinese Association/s would need to make detailed presentations on their respective plans for hosting such conference at the next ISC Council meeting due to be held in Paris in May 2009.

At meetings of the CRIMSA EXCO and Council on 12 & 14 August 2008 this matter was discussed in considerable detail. Thereafter the following President's Resolution was put to the meeting for a vote (and circulated on e-mail to Council members unable to attend for their vote as well):

**“TAKING IN TO ACCOUNT ALL OBSTACLES AND OTHER CONSTRAINTS (FUNDING, PERSONNEL, ORGANIZATIONAL BURDEN, VENUE CHOICE, ISC DATE CHOICE, INFRASTRUCTURE (TRANSPORT & FACILITIES) AND SAFETY CONCERNS IN SOUTH AFRICA) CRIMSA COUNCIL TO DECIDE IN PRINCIPLE WHETHER TO PROCEED WITH THE APPLICATION TO HOST THE ISC 2014 CONFERENCE IN SA OR TO DECLINE THIS OPPORTUNITY TO HOST THE 2014 ISC CONFERENCE?”**

Based on the almost unanimous support the go-ahead was given to the CRIMSA President, Prof. Minnaar, accompanied by the vice-president, Prof Christiaan Bezuidenhout, to attend the ISC Board meeting in Paris in May 2009. A presentation (printed hard copies and a powerpoint) was developed and presented to the full ISC Council meeting on the morning of 23<sup>rd</sup> May and to the full ISC Scientific Committee in the afternoon. The Chinese delegation had decided to withdraw their offer to host 2014 ISC congress (and to become an associate society in the organising of the 2011 congress in Japan) but the Mexican Society of Criminology also submitted a written

offer to host the 2014 Congress. Informally, members of both the ISC Board and Scientific Committee complimented CRIMSA on the advanced planning and detail of our presentation.

In the light of the Mexican proposal the ISC Board requested that the full presentations be e-mailed to them for further discussion. After the President of the ISC, Prof Tony Peters, had further talks with the Paris Secretariat, the ISC were able to confirm that they (ISC) “approve these proposals and accept them as the basis for further collaboration for the organization of the XVII<sup>th</sup> World Congress for Criminology of the International Organization of Criminology in South Africa in 2014”.

Furthermore the ISC informed CRIMSA that: “As you yourself plan we will be in contact and will collaborate with you to define the place where the event finally will take place and how the general theme and subthemes will be further developed and outlined. Therefore we have plenty of time and will have several opportunities to meet with the Board and exchange ideas. The ISC will also take care to inform members, visitors and participants in ISC activities directly and through the ISC website. We wish you all the best in the further development of this important project.” From this ISC communication it appears that CRIMSA have to give annual progress reports updating the status of our organisation of such congress and that final approval (official announcement) will be made at the 2011 congress in Kobe in Japan.

The hosting of the 2014 ISC Congress in South Africa will no doubt take a huge organisational effort and co-operation from all members. Advance planning is already underway in terms of developing an Action Plan, making a final decision regarding a suitable venue, setting up a planning/organising committee, soliciting sponsorships, government support and buy-in etc.

**MONASH/CRIMSA VICTIMOLOGY COLLOQUIUM 2009: ADVANCING VICTIMOLOGY ON THE AFRICAN CONTINENT**

On the 6<sup>th</sup> of May 2009 Monash University South Africa hosted the CRIMSA Victimology colloquium: Advancing Victimology on the African continent. The invitation of this colloquium was widely circulated and drew in presenters, attendees and students from different levels of academia, Victim Assistance Providers and Governmental departments (local and international).

The colloquium was opened with a presentation by Mr. Frederich Affolter of the United Nations’ Office on Drugs and Crime. His presentation dealt with the Institutional capacity

and developmental needs of government departments supporting the government of South Africa's 'Victim Empowerment Program'.

This thought provoking presentation was followed by Anneke Meerkotter, who is director of the Tshwaranang Legal Advocacy Centre. Her presentation focused on women's help seeking in Acornhoek, Mpumalanga.

In all there were six presentations and given the level of scholarly debate all presentations could have been as easily part of an international discourse on victims and victim. During this colloquium, current bonds between academia and victim service providers as well government was solidified and new bonds and ideas were also developed. During the closing ceremony of the colloquium all that attended and presented agreed that more of such one day discussion/presentation colloquiums should be held.

**BRITISH SOCIETY OF CRIMINOLOGY CONFERENCE: A 'Mirror' or a 'Motor'. What is Criminology For? CARDIFF, UNITED KINGDOM. 29 June to 1<sup>st</sup> July 2009**

The theme of this year's British Society of Criminology conference, held in the magnificent Cardiff City Hall in the middle of the British summer, was selected to foster debate, dialogue and reflection about how we collectively and individually engage with issues of crime, disorder, social control, punishment and justice in the world around us. The substantive content of the conference engaged directly with some of the pressing problems of the day. To this end, a specially convened session on 'Torture and Human Rights', a number of panels on 'white collar' crime and its regulation and contrasting perspectives on issues of research design in criminological studies proved extremely enlightening.

Key note speakers were Prof Gary Marx (social, cultural, ethical and policy considerations associated with various surveillance technologies) and Prof Lawrence Sherman; author of numerous controlled field experiments testing major theories of crime prevention and criminal sanctions. The South African criminology community will no doubt remember Prof Sherman's participation at the 2007 CRIMSA conference and more recently his publication on experimental criminology in *Acta Criminologica*. Professor Stanley Cohen, whose contributions have consistently proved to be reference points in the development of criminology, was honoured as the first recipient of the BSC Prize in criminology; intended to celebrate outstanding contributions made to the discipline of criminology, either by a single contribution or through the production over time of a body of work.

The publishers' exhibition stands were well represented with the major publishing houses (Willan, Sage, Routledge) displaying current academic publications in criminology and criminal justice.

### **NON-ADVERSARIAL JUSTICE**

The Federation Press has recently published a book on Non-Adversarial Justice by Monash University Law Faculty scholars Dr Michael King, Professor Arie Freiberg, Dr Becky Batagol and Mr Ross Hyams.

This book outlines key aspects of a growing trend within the Australian, United States, Canadian, New Zealand, United Kingdom and other legal systems towards the use of non-adversarial justice.

It examines in detail non-adversarial theories and practices such as therapeutic jurisprudence, restorative justice, preventive law, creative problem solving, holistic law, appropriate or alternative dispute resolution, collaborative law, problem-oriented courts, diversion programs, indigenous courts, coroners courts and managerial and administrative procedures.

It identifies the common themes, values and principles that bring these disparate theories and practices together and explicates them for practitioners, courts and students. It examines the implications of these changes on legal practice, the courts and legal education.

## **CRIMINAL JUSTICE SYSTEM IN GERMANY: RESULTS OF PRELIMINARY PROCEEDINGS IN CRIMINAL CASES**

More than half of the preliminary proceedings were discontinued by the Public Prosecution Office in 2006. As reported by the Federal Statistical Office, the Public Prosecution Office at the regional courts and the local courts dealt with approximately 4.877.00 preliminary proceedings in 2006. After the continuous rise of the number of proceedings recorded in the last decade (1995: 4,204,000), the cases are moderately declining since 2004 (4,995,000). In 1.19 Million proceedings of all 4.99 Million preliminary cases recorded in 2006 the Public Prosecution Office either brought a charge against the accused to the relevant court or applied for a panel order resp. applied for an accelerated/simplified proceeding when juveniles were involved.

On the other hand 2.6 million proceedings (53%) were discontinued due to judicial reasons e.g. the investigation did not provide sufficient indications) or due to opportune reasons (e.g. if the offender's guilt is of a minor nature). The remaining 1.09 million cases (22%) were dealt by the Public Prosecution Office by miscellaneous settlements, essentially by application to another public institution or in connection with additional offences.

Most of the proceedings were terminated because there was no public interest of prosecution. In 2006 1.3 Million (27%) proceedings were discontinued because the investigations did not provide sufficient indications or the suspect was incapable of guilt resp. there were some procedure obstacles. Furthermore 27% of the proceedings were terminated for opportune reasons, among them 240.000 (5% of all cases) involving the imposition of certain conditions.

Since 1995 the share of all discontinued proceedings compared to all cases amounts at a constant level between 53% and 55%. On the other hand the share of the indictments in a further sense declined in the same period from 29% to 24%, the share of miscellaneous cases did increase reflectively.

Four out of five preliminary proceedings were opened by the police in 2006. 17% of all proceedings were initiated by the Public Prosecution Office, 3% of all cases were opened by an administrative authority (incl. tax administration and customs administration). From the opening until the settlement the proceedings lasted for 3.3 months on average. The procedure duration of all cases in which the Public Prosecution Office brought a charge against the accused to the relevant court in 2006 was 4.2 months on average.

In 2006 approximately every fifth preliminary proceeding referred to a traffic offence, 17% referred to fraud, 15% referred to theft and embezzlement and 9% referred to bodily harm See also Table at:

## **PRISONER RATES IN EUROPEAN COUNTRIES 2008**

## **SPECIAL GROUP ON ORGANIZING CRIME ON THE OCCASION OF THE APROS CONFERENCE IN MONTERREY, MEXICO, 6-9 DECEMBER 2009**

For the APROS-Conference (<http://www.egade.itesm.mx/apros2009/index.html>) a stream under the title “organizing crime” is being convened. This stream invites contributions which look at the field of organized/professional crime. Despite its dominance in the media “organized crime” is a widely unexplored and neglected field. The highly covert and elusive nature and the “hypocrisy of legal imperatives, and ignorance masquerading as moral outrage” (Hobbs, 1995: 8) lead to a lack of academic attention.

Extensive television coverage (Smith, 1975) and the exploitation of stereotypes by the entertainment industry shape our visions of criminal organizations. Empirical studies show that illegal market activities are quite different from the images depicted by the media. Research suggests that professional criminal activities like drug distribution are highly sophisticated (Adler, 1985), take place in “disorganized” ways (e.g. Reuter, 1983) and are characterized by a fluid social system (Kenney,2007). Risks of persecution and detection lead to a creative unfolding of the organizing activities.

This stream invites papers from a wide range of disciplines and perspectives dealing with the organization of criminal activities. This might include: Drug distribution, arms trafficking, professional theft, terrorism, human trafficking, identity theft, gambling, money laundering, corruption, and insider trading.

We encourage submissions that could contribute to our understanding of “organized crime/organizing crime”. Novel theoretical frameworks and innovative research strategies are welcome to open the field for researchers interested in organizations and organizing.

“The practice at the ICTY and ICTR has shown that there is no real international criminal (customary) law, but only extrapolations from international public law, general principles of law and humanitarian law. The divide between the so-called common law and civil law systems and their differences in approach to solving legal problems make it necessary to establish an international forum for discussion and development of a common ground on which the work of the international courts can build. This is especially true with regard to the so-called "General Part" of the substantive criminal law, like forms of participation, /actus reus/ and /mens rea/ categories, defences and excuses, offence types, sentencing, enforcement etc. But also the procedural law still lacks sharp features in many aspects; the ICC's Rules of Procedure and Evidence will be in need of interpretation. In addition, it will be helpful to the Courts to understand the societal background and effects of the law.
